

DESCRIPTION

TAL GLINT is a special blend of mild chemicals and detergents, designed to clean and shine ceramic, porcelain, granite, quarry and terracotta tiles and vinyl resilient flooring.

It will also rejuvenate grout and remove calcareous deposits, unmodified cementitious deposits, grease and soap residues.

TAL GLINT is not recommended for use on marble or terrazzo (concrete/cement) tiles or linoleum flooring.

TAL GLINT may be used for cleaning the following areas :

- **Kitchens** - all ceramic and porcelain wall and floor tiles and grout, as well as granite counter tops
- **Bathrooms** - wall and floor tiles, shower tiles and mosaics, sanitary ware
- **Swimming Pools** - ceramic tiles, mosaics and coping tiles

CAUTION

- Not suitable for use on linoleum.
- Do not use on marble or terrazzo/cement tiles.
- Do not mix with other chemicals.
- Do not allow to freeze.

PREPARATION

It is important to ensure that floors are thoroughly swept to remove surface dust, debris, etc prior to cleaning.

DILUTION

Recommended dilution is 1:10 (100ml / 1 litre) with clean cold water. Increase the concentration for heavier stains.

APPLICATION

- **Cleaning of Tiles**
This product is used in the manner of a general household cleaner. Rinse the area with clean water.
- **Cleaning of Grout**
The undiluted product is liberally applied to the grout. A soft scrubbing brush should be used to help remove the loosened dirt. Rinse the TAL GLINT off with clean water. Grout should be sealed afterwards using a suitable sealer, using TAL GROUT SEALER.

COVERAGE

Varies considerably depending on dilution and application.

PACKAGING

TAL GLINT is available in 1ℓ plastic bottles.

STORAGE & SHELF LIFE

When stored in dry internal conditions between 10° C and 30° C and out of direct sunlight the product has a shelf life of 6 months from date of manufacture. Do not allow to freeze. **Ensure lid is tightly sealed.**
